

# **Development of Debt Policy**



4.12.2 **Two-thirds vote** (or such greater vote as required by state law) of the appointed Directors shall be required to take any action on the following:

(a) Issue bonds or other forms of debt;

# **Additional Policy Elements**

SDCP has added three additional requirements to its proposed debt policy which are not required by local, state or federal law.

# **Green Bonds**

To the extent possible, SDCP bond issuances shall be green bonds. A green bond is a type of fixed-income instrument that is specifically earmarked to raise money for climate and environmental projects.

# Pledged Revenues

No less than one and a half times (1.5x) the maximum annual principal and interest and debt service for the aggregate outstanding senior lien bonds including the debt service for the new issuance.

## Annual Debt Service

Long-term debt shall not exceed 5% of the Agency's annual total expenses.



# **Permited Debt Types**

SDCP may legally issue both short-term and long-term debt, through either a direct loan or through the public market, using the debt instruments described below.

## **Long-Term Debt**

- Finance capital expenditures
- Structured within expected useful life

## **Short-Term Debt**

- Interim funding pending long-term debt
- Maturity generally less than 7 years

## Variable Rate Debt

Long-term variable rate debt as needed

## **Refunding Debt**

- Refinance bonds
- Achieve debt service savings
- Restructure debt service payments
- Modify covenants
- Reduce exposure to counterparties



# Example – Long-Term Debt (Revenue Bond)

# Example (Revenue Bond): SDCP issues a \$500 million revenue bond to construct a solar and storage project.

- Loan amount: \$500,000,000
- ➤ Interest Rate: 5.00%
- > Pledged revenues: Ratepayer revenue
- > Repayment Term/Useful life: 20 years

## **SDCP Additional Bond Tests**

- 1. **Green bonds** earmarked to raise money for climate and environmental projects.
- 2. Pledged revenues will be no less than one and a half times (1.5x) the maximum annual principal and interest and debt service for the aggregate outstanding senior lien bonds including the debt service for the new issuance.
- **3. Annual debt service** on long-term debt shall not exceed 5% of the Agency's annual total expenses.

# Background

Section 5.10.3 of the SDCP Joint Powers Authority (JPA) Agreement:

"Each Party may nominate a committee member(s) and the Board shall determine the final section of committee members, who should represent a diverse cross-section of interests, skills sets and geographic regions."

At the December 2021 Board Meeting, the makeup of the CAC was updated to fourteen (14) primary members, with two from each member agency.



#### Community Advisory Committee Membership Terms and Criteria

- The Committee shall be made up of fourteen (14) primary committee members, with two (2) from
  each member agency. If another member agency is added beyond a total of seven, the CAC will
  move to one primary and one alternate member for a total of seven (7) primary committee
  members. This composition may be revisited by the Board if new member agencies are added to
  SDCP.
- 2. The CAC is a Brown Act Committee and all meetings shall be posted and held in public settings;
- SDCP aims to ensure a wide variety of perspectives and participation on the Community Advisory Committee:
- Members shall be residents (property owners and/or renters), business owners, employees or representatives of a community-based organization located within one of the member agencies of San Diego Community Power;
- When reviewing applicants for membership, SDCP staff and the Board of Directors are to prioritize residents, when feasible, from diverse social, economic and racial backgrounds that are representative of all residents within the service territory of San Diego Community Power;
- There shall be at least one CAC member that is a renter within SDCP's service territory and one that is a business owner.
- Applicants must be committed to serving on the CAC and attending regular committee meetings, and occasional SDCP Board meetings. CAC meetings, times, and location will be determined in collaboration with staff. Members will serve a limit of two, three-year staggered terms.
  - a. Odd Seats current term ends 2022 and will renew to 2025 on July 1, 2022.
  - b. Even Seats current term ends 2023 and will renew to 2026 on July 1, 2023.

Adopted January 30, 2020 and Updated December 2021



# **Analysis & Discussion**

- County of San Diego application open period:
  - ✓ Released in September 2022
  - ✓ Open until filled
- Qualifications were based on residence or work impact
- A total of 8 applications were received for County of San Diego
  - ✓ 7 applicants qualified for the County of San Diego
- Members will serve a limit of two, three-year staggered terms

## Background:

VAMO = Voluntary Allocation + Market Offer

## Voluntary Allocation (VA):

PCIA eligible LSEs offered voluntary allocation of their IOUs Long-term portfolios

## Market Offer (MO):

Long-term Market Offer of remaining PCIA eligible RPS volumes

- CPUC directed
- Overseen by independent evaluators
- Bidding conducted by all 3 IOUs simultaneously

# Item 13: PG&E Market Offer Contract

## **Contract Summary:**

- Start Date: Upon approval by CPUC (expected in Q3 2023)
- End Date: Expiration of PG&E's relevant PCIA-eligible renewable energy supply contracts (expected in 2043)
- Structure: Index plus fixed-price renewable premium
- Price: Confidential
- Portfolio Slice "Election" Quantity: Confidential while PG&E completes MO solicitation process
- Estimated Annual Generation: Confidential. Varies by year, subject to intermittent resource generation, and declining over time as PG&E's relevant PCIA-eligible renewable energy contracts expire


