RECOMMENDATION

Approve Renewable Power Purchase Agreement with ORNI 30 LLC for a term of 20 years and authorize the CEO to execute the agreement.

BACKGROUND

As San Diego Community Power (SDCP) strives to meet its environmental, financial, and regulatory compliance goals and requirements, long-term power purchase agreements (PPAs) of at least 10 years in duration are integral components of its energy supply portfolio. Long-term PPAs provide renewable generation facility developers with the certain revenue stream against which they can finance up-front capital requirements, so each long-term PPA that SDCP signs with a developing facility will underpin a new, incremental renewable energy project. In addition, long-term PPAs lock in renewable energy supply around which SDCP can build its power supply portfolio while also providing power supply cost certainty around which SDCP can develop its pro forma financial model.

Moreover, the California Renewable Portfolio Standard (RPS), as modified in 2015 by Senate Bill 350, requires that SDCP provide 65% of its RPS-required renewable energy from contracts of at least ten years in length. Finally, in D.21-06-025, the California Public Utilities Commission (CPUC) required each Load Serving Entity (LSE) in California to make significant long-term purchase commitments for resource adequacy from new, incremental generation facilities that will achieve commercial operation during 2023 through 2026.

The proposed PPA is for capacity and renewable energy benefits from a 42 MW solar and 35 MW, 4-hour battery energy storage facility (currently referred to as the "Brawley

Solar and Storage Project") with ORNI 30 LLC, a subsidiary of Ormat Technologies, Inc. (Ormat) and wholly owned by Ormat Nevada Inc. The PPA originated from an offer SDCP received in 2020 via its Request for Proposals (RFP) For Long Term California RPS-Eligible Renewable Energy solicitation. After initial negotiations on terms, negotiations were paused due to pandemic-related supply chain impacts. This year SDCP reengaged with Ormat and have reached terms mutually agreeable to both parties.

ANALYSIS AND DISCUSSION

Staff negotiated the attached PPA for the purchase of renewable energy and resource adequacy from the Brawley Solar and Storage Project, which is a solar-plus-battery-storage project to be developed in the City of Brawley in Imperial County by Ormat.

The project is located on land previously designated as non-prime agricultural land and is located adjacent to Ormat's existing geothermal facility and to the City of Brawley's wastewater treatment plant. The project will have a guaranteed capacity of 42 MW of solar production and 35 MW of battery storage capacity. The capacity will be determined by the Import Allocation that SDCP is able to secure via an annual CAISO process that will allow SDCP to claim the capacity as Resource Adequacy and toward the CPUC's mid-term reliability ("MTR") requirements for SDCP. As previously reviewed with the Ad Hoc Energy Contracts Working Group, the contract offers competitive energy and capacity prices.

The draft PPA specifies that the Seller commits to making reasonable efforts to ensure at least 80% of all employees hired by Seller, its contractor and subcontractors are local to Imperial County and/or union labor and will provide reporting to SDCP to demonstrate such efforts. Ormat was recently able to achieve a 90% benchmark at the nearby Wister Solar project in Imperial County.

Ormat is also committed to the development of a workforce clean energy or battery storage workforce training program, or science, technology, engineering, and math (STEM) educational program, located within 20 miles of the project. These dollars go to Ormat's vendor, and curriculum is provided to SDCP.

Renewable energy produced by the facility will be an important ~120 GWh/year foundation of long-term, locally sourced renewable energy deliveries within SDCP's power supply portfolio.

Below is additional information regarding Ormat and the draft PPA.

Background on Ormat.

Ormat Technologies Inc was established in 1965.

- Ormat has a current generating portfolio of over 1 GW spread globally in the U.S., Kenya, Guatemala, Indonesia, Honduras, and Guadeloupe. This is comprised of geothermal, solar, and waste heat recovery plants.
- Ormat has a current operational battery energy storage portfolio of 107 MW in the U.S. with an additional 204 MW / 464 MWh of BESS currently under construction in CA, TX, NJ, and OH.
- Notable projects in Imperial Valley include:
 - Ormesa Complex (36MW) Imperial Valley (geothermal) Oldest unit brought online in 1985, Newest in 2007
 - Heber Complex (81MW) Imperial Valley (geothermal) Oldest Unit brought online in 1985, Newest in 2008
 - Brawley (7MW) Imperial Valley (geothermal) online in 2010
 - Wister Solar (20MW) Imperial Valley (solar PV) online in 2022

Contract Overview - ORNI 30 LLC

- Project: 42 MW Solar, 35 MW/140 MWh lithium-ion battery energy system
- Project location: Brawley, Imperial Co, CA
- Guaranteed commercial operation date: April 15, 2025
- Contract term: 20 years
- Expected annual energy production: approximately 122,000 MWhs
- Guaranteed energy production: 85% of projected annual deliveries
- Energy price:
 - Solar Fixed energy price applicable to the full term of the agreement
 - BESS Fixed capacity price adjusted for availability and verified capacity
- No credit or collateral obligations for SDCP
- Allows for the parties to source bridge capacity product for MTR compliance purposes
- Committed to at least 80% local hire and/or union labor
- Committed to hiring union-employed c-10 electrical contractors with certified electrical technicians
- Committed to a 20% journeyman/apprenticeship ratio for the Qualifying contractor's work in a joint labor/management electrical apprenticeship
- SDCP would receive financial compensation in the event of seller's failure to successfully achieve certain development milestones as well as seller's failure to meet the guaranteed energy production from the solar facility and failure to meet guaranteed efficiency from the storage facility once the project is operational.

COMMITTEE REVIEW

Key terms of this PPA were reviewed with the Energy Contract Working Group (ECWG) on June 12, 2023, and the ECWG recommended to move forward with the execution of this PPA.

FISCAL IMPACT

The competitive energy and capacity pricing of the PPA are confidential, but the long-term purchase of renewable energy and capacity will provide SDCP with significant value and cost certainty over the term of this PPA.
