Background

SDCP currently offers two levels of services.

PowerOn
54.2% Renewable

Power100
100% Renewable

PowerOn – standard service offering with a minimum of 50% renewable power

Power100 – premium service with 100% renewable and carbon-free power

- \$0.0075/kWh adder
- Adjusted to \$0.01/kWh as of July 1, 2024

Customer Feedback and Needs


LEED Certification and SEC Disclosures

- Commercial and industrial customers desire a stand-alone 100% renewable and carbon-free Green-e® certified service
- Cater to Leadership in Energy and Environmental Design (LEED) rating goals
 - LEED is the world's most widely used green building rating system
 - Power100 Green+ will allow for project/buildings to earn LEED renewable energy points towards certification
- Cater to Securities and Exchange Commission (SEC) rules to enhance and standardize climate-related disclosure

Power100 Green-e Certified

Service Offering Details

- Effective as of July 1, 2024.
- This new service will be called Power100 Green+
- Priced as a \$0.02/kWh adder to PowerOn.
- Initially available to commercial and industrial customers.
- Expects 2% of load will enroll; enrollment will be capped at 5% of load unless modified by the Board.
- Fiscal Impact:
 - \$3.2 million in net annual revenue.
 - Estimate factored into fiscal projections reviewed and approved by the Board in SDCP's 2024 Rates Schedule.
- Sourced primarily from resources under long-term contract to SDCP: Duran Mesa (wind), IP Oberon (solar), Vikings Energy Farm (solar)

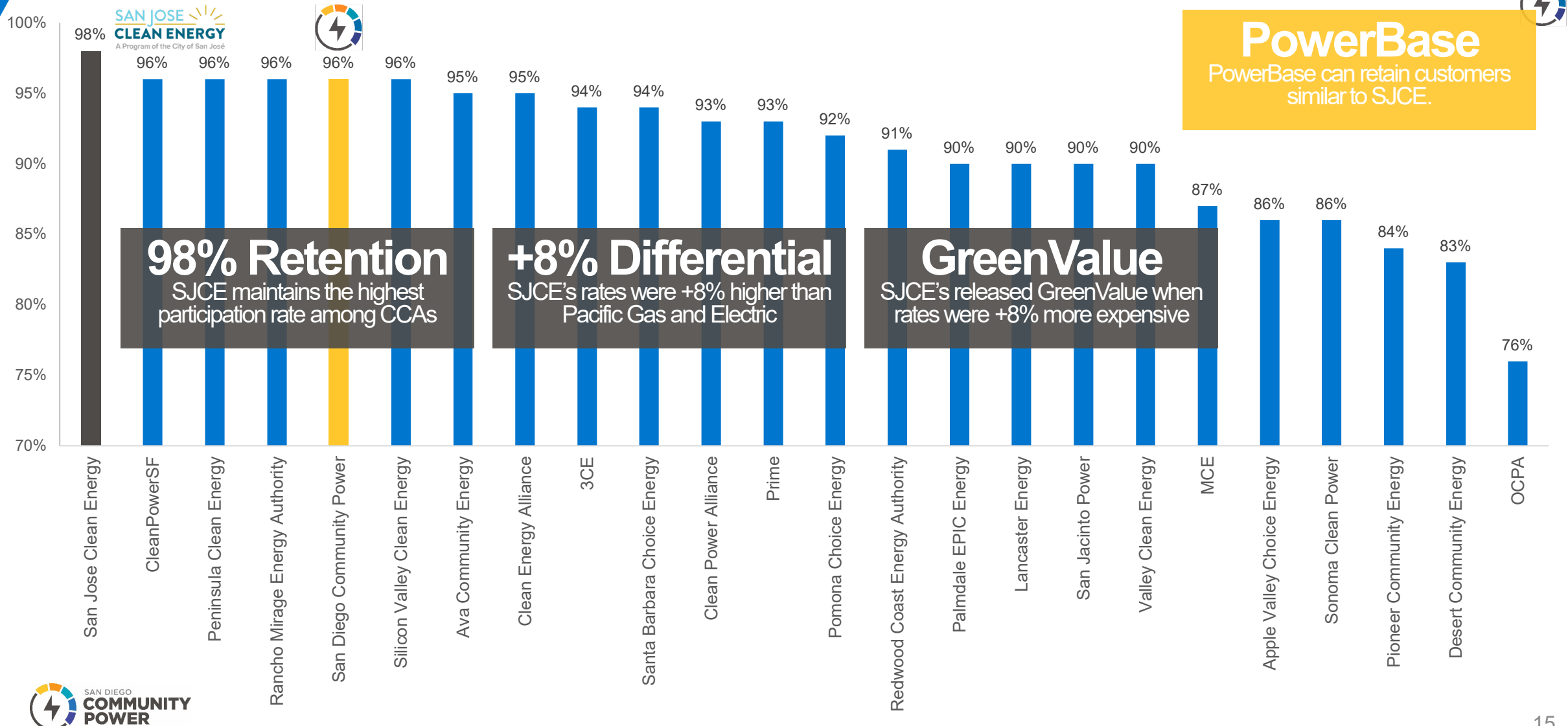

Customer Choice and Needs

Balance competitive rates with SDCP financial stability

- Proposal enhances customer choice and meets the diverse needs of SDCP customers with a focus on affordability
- Proposal intends to mitigate opt-outs and assist in maintenance and accrual of reserves
- Initially offer rates that are 2.5% lower than SDGE's existing default service commodity rates that are effective as of March 1, 2024
- Closely aligned with the State of California's Renewable Portfolio Standards (RPS)

Participation Rates by CCA



PowerBase
PowerBase can retain customers similar to SJCE.

98% Retention
SJCE maintains the highest participation rate among CCAs

+8% Differential
SJCE's rates were +8% higher than Pacific Gas and Electric

GreenValue
SJCE's released GreenValue when rates were +8% more expensive



SDCP Financial Impacts

Difference	\$ 39,923,370	\$ 39,738,044	\$ 185,326

- The PowerBase product **preserves customer participation** which by comparison to other CCAs is difficult to rebuild once it declines.
- In FY 2024-25, staff do not anticipate a substantial impact to net income if PowerBase is approved.



PowerBase

Service Offering Details

- Initially offer rates that are 2.5% lower than SDGE's existing default service commodity rates that are effective as of March 1, 2024.
- Not eligible for member agency-wide default service changes.
- Capped at no more than 15% of participating load; when 10% participation by load is reached, staff will return to the Board.
- Supports SDCP's mission to provide an affordable option that is cleaner than the competition.
- Supports SDCP's mission to achieve 100% renewable energy by 2035 or sooner through customer retention, especially for price sensitive customers.
