## A purchase will not improve chances of winning.

By entering this drawing, entrants accept and agree to be bound by these Official Rules. Any violation of these rules may, at SDCP's discretion, result in disqualification. All decisions regarding this drawing are final and binding in all respects.

- SPONSORSHIP & ADMINISTRATION. This Drawing is sponsored and administered by San Diego Community Power ("SDCP"), 815 E Street, Suite 12716, San Diego, CA 92112.
- 2. **DRAWING PERIOD.** Drawing begins 9:00 AM PT on 08/29/22 and ends 12:00 AM PT 10/01/22 ("Drawing Period") subject to extensions. Online entries must be received by the end of the Drawing Period.
- 3. **ELIGIBILITY.** This drawing is only open to residents of the City of San Diego, City Chula Vista, City of La Mesa, City of National City, City of Imperial Beach, and City of Encinitas, and County of San Diego who are at least 18 years old as of the date of entry, except officers, directors, members, and employees of SDCP, Administrator, or any other party associated with the development or administration of this Drawing, and the immediate family (i.e., parents, children, siblings, spouse). This Drawing is void outside the jurisdictions listed before, and where prohibited. Entrants shall be required to provide a valid mailing address located within the above-listed cities/unincorporated areas
- 4. HOW TO ENTER. Visit <u>https://www.SDCommunityPower.org/survey</u> during the Drawing Period and follow the instructions to complete and submit the survey and entry form. All entries become the property of SDCP and will not be acknowledged or returned. Limit: One entry per person and per household (based on mailing address). Duplicate entries for the same person or household will be discarded. All entrant information, including email addresses, is subject to the respective Privacy Policy of SDCP.
- 5. WINNER SELECTION AND NOTIFICATION. Winner selection will be conducted by random drawing from all eligible entries on or about 10/21/22 (the "Drawing Date"). Any potential winner will be notified by email and/or telephone. If a potential winner: (i) cannot be contacted; (ii) does not respond within five (5) days from the date SDCP first tries to notify them; (iii) refuses the prize; and/or (iv) the prize or prize notification is returned as undeliverable, such potential winner forfeits all rights to win the Drawing or receive the prize, and an alternate potential winner may be selected.
