Solar Billing Plan - Understanding Your Solar Bill



Electric charges and credits:

- 1 **Electric Delivery:** This is the charge from SDG&E for delivering electricity to your location. This charge also includes billing, customer care services and maintaining and modernizing infrastructure.
- 2 **CCA Electric Generation:** This is the charge for electricity used in your home or business. Your electricity is bought or generated by your Community Choice Aggregator (CCA). Two CCA providers serve customers within SDG&E's service territory: Clean Energy Alliance (CEA) and San Diego Community Power (SDCP).
- 3 **Electricity Import kWh:** This shows you how much and when you imported electricity from the grid.
- 4 **Non-Nettable Charges:** These charges are required and not eligible to be offset by Delivery Export Credits or Generation Export Credits. These charges include monthly minimum charges, customer charges, meter charges, facilities charges, basic service charges, demand charges and surcharges, non-bypassable charges and any fixed charges.
- 5 **Delivery Import Charges:** These are charges for delivering electricity to your location, as well as other services, including billing, customer care services, and maintaining and modernizing infrastructure.
- 6 **Delivery Export Credits:** These are credits that are calculated based on how much energy you export to the grid, as well as the value of the energy at that time of day. These energy export credits can only be used to offset Delivery Import Charges.
- 7 **Applied Delivery Export Credits:** The amount of Delivery Export Credits applied to offset any Delivery Import Charges this bill period.

SDG&E year-to-date solar billing plan summary:

- 8 **Estimated Annual True-Up Adjustment:** This is the monthly estimate account for net export compensation that has previously been credited within your true-up period. You will get this estimate of the charge or credit on your Annual True-Up bill.
- 9 **YTD Net kWh:** This is the total amount of energy imported and exported, by kWh, from your solar system. If this value is negative, you've exported more to the grid than you have used.
- 10 **YTD Non-Nettable Balance:** This is the running total of Non-Nettable charges and credits for the current True-Up period.
- 11 **YTD Delivery Balance:** This is the running total of delivery charges and credits for the current True-Up period.
- 12 **YTD Remaining Delivery Export Credits:** These are the amount of Delivery Export Credits available for you to apply to future Delivery Import Charges within the current True-Up period.

Community Choice Aggregation (CCA) electric generation charges:

- 13 **Community Choice Aggregation (CCA) Electric Generation Charges:** As a CCA customer, your electricity is purchased or generated by San Diego Community Power or Clean Energy Alliance. If you have questions about your electric generation charges or credits, please contact your CCA.
- 14 **CCA Electricity Provider:** Your CCA's name and phone number is listed here.
- 15 **Generation Charges:** These charges are for the electricity you used in your home or business.
- 16 **Generation Export Credit Adder:** These credits are calculated by your CCA based on how much energy you export to the grid and the value of the energy at that time of day.
