ADMINISTRATIVE LAW JUDGE’S RULING

Pursuant to the *Administrative Law Judge’s Ruling Seeking Comment on Proposed 2023 Preferred System Plan and Transmission Planning Process Portfolios*, dated October 5, 2023 (“ALJ Ruling”), San Diego Community Power (“SDCP”) hereby submits updated information related to its 2022 Integrated Resource Plan (“IRP”), which was filed in this docket on November 1, 2022.

I. UPDATED INFORMATION SUPPORTING SDCP’S 2022 IRP

Subsequent to SDCP’s submission of its original 2022 IRP filing, the California Public Utilities Commission’s Energy Division has requested that certain supporting documents be updated or modified, including SDCP’s Clean System Power (“CSP”) and Resource Data Template (“RDT”) spreadsheets. The ALJ Ruling requests that LSEs that have updated their supporting documents pursuant to Energy Division request “make a formal filing in the docket of this proceeding with the final version of their RDT and/or CSP calculator, by no later than October 16, 2023, to ensure that the record reflects their correct information.”¹ SDCP hereby

submits the following documents, which represent the most up-to-date information supporting SDCP's 2022 IRP:

- `sdcp_csp_25mmt_preferred_conforming_na_v2` – SDCP's Updated 25 MMT Clean System Power Template, Version 2 (Public and Confidential Version)
- `sdcp_csp_30mmt_preferred_conforming_na_v2` – SDCP's Updated 30 MMT Clean System Power Template, Version 2 (Public and Confidential Version)
- `sdcp_rdtv3_25mmt_preferred_conforming_na_v2` – SDCP's Updated 25 MMT Resource Data Template, Version 2 (Public and Confidential Version)
- `sdcp_rdtv3_30mmt_preferred_conforming_na_v2` – SDCP's Updated 30 MMT Resource Data Template, Version 2 (Public and Confidential Version)

SDCP is filing the confidential, unredacted, versions of its most recent updated CSPs and RDTs under seal with the Commission's Docket Office in accordance with the relevant rules and procedures. SDCP is publicly filing the public, redacted, versions of its most recent updated CSPs and RDTs through a Notice of Availability, which provides links to the public versions of SDCP's updated 2022 IRP documents. SDCP's updated 2022 IRP materials are provided through the following attachments:

The remainder of SDCP's IRP materials, including its 2022 IRP Narrative, and IRP Verification, were not subject to update requests and remain unchanged from the originally filed versions.

II. CONFIDENTIALITY REQUEST

The Ruling provides that “if [an] LSE already filed a Motion to File Under Seal with its original submission, an additional motion with the corrected/updated filing is not required.”² SDCP’s original 2022 IRP was filed concurrently with a Motion to File Under Seal, which sought confidential treatment of certain categories of information provided in SDCP’s IRP filing, including its RDT and CSP documents. The information being provided in SDCP’s updated material is consistent with the information provided in SDCP’s original 2022 IRP submission, and SDCP requests that the same information categories covered by SDCP’s Motion to File Under Seal be protected in this updated filing.

III. CONCLUSION

SDCP thanks the Commission for its time and effort in the 2022 IRP cycle and for its review of SDCP’s Updated IRP information.
