Results for the period overperformed overall compared to the amended budget:

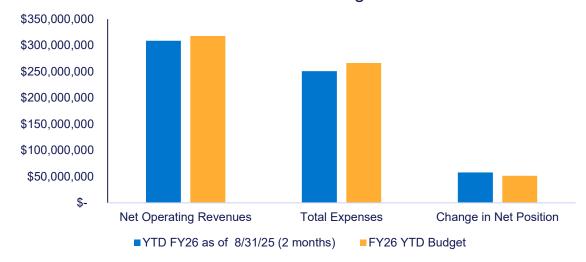
- Net operating revenues 2.9 percent under budget.
- Operating expenses came in (6.0) percentage points under budget.

Financial results for YTD FY26:

- \$308.7M in net operating revenues
- \$250.7M in total expenses (including energy costs of \$223.2M)
- \$58.0M change in YTD net position

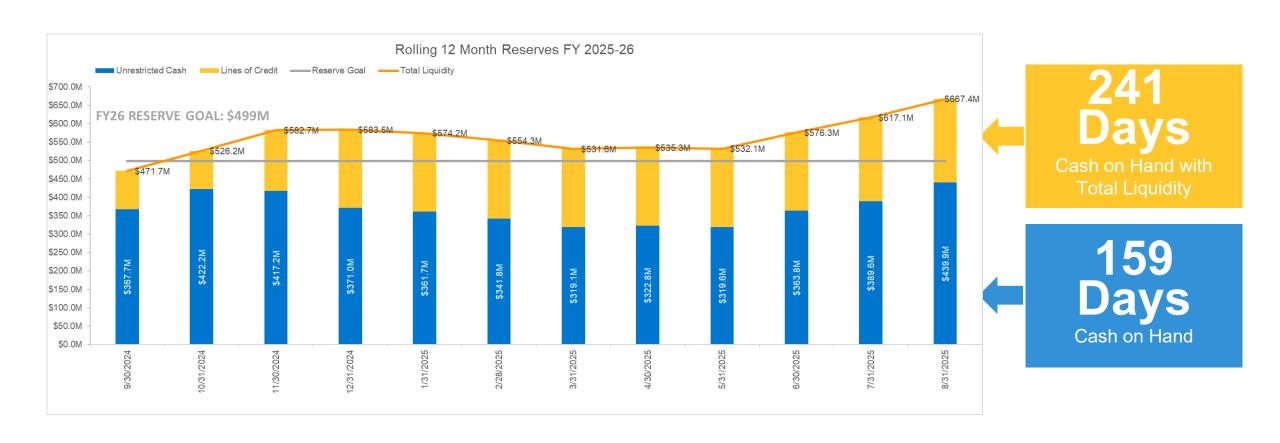

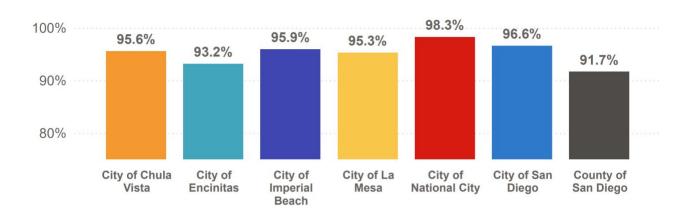
