INTRODUCTION

San Diego Community Power (Community Power) Rates rates are established to meet standard bill comparison targets approved by our Board of Directors. Any changes to Community Power’s rates are adopted at public meetings of our Board. The rates shown in this document are for electric generation/supply only. RATE PERIOD DEFINITIONS

Seasonal Periods

For all rate schedules, seasons are defined as follows:

- Summer: June 1 – October 31
- Winter: November 1 – May 31

All time periods listed are applicable to local time. The definition of time will be based upon the date service is rendered.

Power100 Rate

Power100 charges are applied as a premium of \$0.01 per kWh on top of PowerOn rates. Any premium charges are based on net usage.
